

## 2023 Appraisal Appointment Request

UPDATE 8/14/2023: Chris Moline, our 2023 Appraiser, called on July 25, 2023, to say that she is scheduled for surgery to remove one kidney on Sept 18. She'll need 4 to 6 weeks recovery time so she is disappointed that she cannot be our appraiser this year. She does have a replacement lined up — Lynn Contri. Chris helped mentor Lynn through the AQS certification process several years ago and says we'll be in good hands.

Lynn Contri will be our Appraiser at our 2023 CCQG Quilt Show. She will conduct a 30-minute formal appraisal inspection for each quilted textile item. Each customer will receive a final written appraisal summary, including photos, approximately 2 to 3 weeks after the initial appraisal is completed. Four categories of quilted textiles can be appraised: antique quilts (100 years of age or older); vintage quilts (considered 50+ years old); traditional/contemporary/modern quilts; and wearable art/decorative items. Lynn has been an American Quilt Society (AQS) Certified Quilted Textile Appraiser since 2016. She is also certified by the Professional Association of Appraisers of Quilted Textiles Code of Ethics (PAAQT). Her written appraisal summaries conform to the Uniform Standards of Professional Appraisal Practice (USPAP). She has satisfied the IRS requirements for a qualified appraiser.

Lynn says, "I started to sew at a very young age and learned to use a sewing machine at age 10. I told myself I wouldn't learn to quilt until I was a grandmother. The day my daughter told me she was expecting, I signed up for a quilting class. The twins are 21 now and I have had great quilting experiences since that day. After making quilts, I wanted more, so I started attending many quilt shows and quilt lectures near and far. At one fabric study class, I got hooked. I never realized there was so much to learn about fabrics." Lynn has attended the annual AQS appraising classes offered in Paducah, Kentucky, since 2008. These classes, plus others she's taken, cover topics such as ethics, dating, construction, regional differences, care, preservation, textile history, and social history. Lynn says, "I have a reference library and continue to keep up on the current market conditions. I belong to several fabric study groups and hold memberships and board positions in several guilt and textile organizations."
