



2025. Colors in Motion Quilt Show Rules and Regulations

1. **QUILTS MUST BE CLEAN** – NO STAINS, FOOD OR ANIMAL HAIR ON THE QUILT AND NO SMOKE OR OTHER ODORS.
2. Quilts must be constructed of at least 3 layers: the top, the middle layer (can be of batting, such as cotton, flannel, wool, etc.), and the backing.
3. The Show Committee or Judge reserves the right to refuse a quilt.
4. The Judging Committee and/or the judge reserves the right to re-classify any entry. Not all entries will be awarded a ribbon.
5. Judged entries must be entered by the maker (in the case of Group quilts, one of the makers). Only judged entries are eligible for Judge's awards. Other awards may be granted as determined by the Show Committee.
6. Entries are limited to 3 per person per category. Entries in GROUP are limited to 3 per group but each person in the group may enter with other people.
7. Quilts may not have been entered in a previous CCQG show.
8. Entry is open to anyone. Entry fees for CCQG members are \$15 for the first quilt entered and \$8 for each additional judged entry, \$5 for exhibit only quilts. Entry fees for non-CCQG members are \$25 for the first quilt entered and \$10 for each additional judged entry. Non judged entries from a non-guild member will be \$7 with guild members getting priority of limited display space. Entry fees are non-refundable. **A CCQG member must be an active member as of January 1, 2025**
9. Entry fee for the Junior Category (18 and under) is \$5. This is a non-judged category. Juniors may enter in other categories but will need to pay for each judged entry as stated in #6 above.
10. Labels will be supplied upon intake and attached to the quilt. (If you have a label on the quilt, please cover it with similar fabric.)
11. Please do not bring items to be attached to the quilt for hanging (photos, etc.) If you wish, you may send a photo with the story of the quilt at the time of registration. These will be hung at the discretion of the Hanging Committee.

12. All entries must have a 4" hanging sleeve attached, optional for Categories 3, 4, 5, and 6. See additional handout for directions on making the correct sized sleeve. If the incorrect sized sleeve or if no sleeve is attached to the quilt, the quilt will be rejected at intake and must be removed.
13. Judged entries must be entered by the maker (in the case of Group quilts, one of the makers). Only judged entries are eligible for Judge's awards. Other awards may be granted as determined by the Show Committee.
14. Quilting must be evident on all judged entries. The judge must be able to see the quilting through all layers, on the front **and** back of the work.
15. ALTHOUGH ALL POSSIBLE CARE AND ATTENTION WILL BE GIVEN TO PROTECT EACH ITEM ENTERED, CABLE CAR QUILTERS GUILD AND THE DUBUQUE COUNTY FAIRGROUNDS ACCEPT NO RESPONSIBILITY FOR LOSS OR DAMAGE. It is the responsibility of the quilt owner to insure their own items – generally you will need a rider on your homeowner's policy.
16. **Registration Information:**
 - a) Registration opens June 16th 2025.
 - b) Electronic registration must be received by August 25th, 2025. Payment is due on September 15, 2025.
 - c) Mailed paper registration must be postmarked by August 25th, 2025. Payment is due by September 15, 2025. Please allow for adequate mail time.

17. DELIVERY & PICK-UP

- a) All items must be hand-delivered on Wednesday, October 15, 2025 between 9 am and noon to the 4H Building at the Dubuque County Fairgrounds, 14583 Old Highway Road, Dubuque, Iowa. Entries will NOT be accepted before 9 a.m. or after 12 o'clock noon. Please fold quilts so that the bottom left corner of the back of the quilt is on top. This is where we will attach the label.
- b) All items must be picked up on Saturday, October 18, 2025, after all quilts are taken down and sorted, approximately between 5p.m. & 5:30 p.m. in the Grand Ballroom at the Dubuque County Fairgrounds. NO ITEMS will be released before this time. The receipt received at intake must be presented at pickup as proof of ownership. A \$25 late fee per item will be charged for any items not picked up during the scheduled time.
