2025 Appraisal Appointment Request

Chris Moline, an American Quilter's Society (AQS) Certified Quilted Textile Appraiser, will appraise your quilt items. Appraisals will be given for antique and contemporary (including art) quilts of all sizes and quilted textiles (including but not limited to garments, wall hangings, bed size quilts, & quilt tops).

APPRAISAL GUILDELINES: Quilted items and quilt tops of an estimated value of \$300 or more are suitable for appraisal unless part of a collection. All items of a collection, where the average value exceeds \$300, should be appraised. The appraiser may decline to do an appraisal for items of lesser value, or outside her area of expertise at no charge. With advanced notice, Chris will also appraise woven coverlets, knit, crochet or tatted table and bed linens, Kashmir shawls and other table linens; however, there is no certification to cover these specialty appraisal items.

Appraisals will be given using a form and format approved by the American Quilter's Society and USPAP (Uniform Standard of Professional Appraisal Practice) and have been accepted by major quilt show venues (AQS, IQA, Mancuso, etc.), major insurance companies, the IRS and courts of law in Illinois, lowa, Indiana, Louisiana, Colorado, and Wisconsin. Chris's appraisal reports are hand written to stave off the possibility of forgery or alteration, which has become an increasing problem in recent years. Appraisal forms are copyrighted which also precludes posting on the Internet or any public forum in electronic form. Neither the IRS nor USPAP standards require photos to be included with any appraisal. However, if arranged with Chris at the beginning of the appraisal process, photos of the quilt can be provided by mail for an additional \$5.00 to cover printing and mailing costs. Appraisals are delivered immediately except in the rare occasion that additional research is required. In those circumstances, a provisional report is provided on site and an amended final report is provided within 2 weeks.

 Your appointment time cannot be reserved until CCQG receives your completed Appraisal Appointment Request information and payment. Walk-in appraisals will be accepted in time slots not pre-assigned. - 2. Your appraisal will be for insurance/replacement value unless you specifically request another type, such as market value or donation value.
- 3. You may bring in a quilt item to be appraised or have your quilt item appraised while it is being displayed at the show. (One appraisal item per half hour).
- 4. Arrive 10 to 15 minutes before your scheduled appointment time. You must be present during the appraisal. If your quilt item is displayed at the show, you will escort the appraiser to your quilt item. Bring Maker's Resume (fame, publication, awards) & Provenance/History (if known).
